GENERAL JOB DESCRIPTION

A home medical consultant provides comprehensive exams, diagnostic testing, and treatment for several illnesses. Patients who are home-bound can now establish a relationship with one doctor who can treat them at home, as well as between appointments with their primary care provider. Medical home visits are helpful to those patients who require an acute office visit but may not leave home because of falls, dementia, other mental health diseases, being bedridden, large pressure ulcers, immunocompromised, weakness, immobility or mobility limitations, lack of transportation or support with activities of daily living. The home medical consultant ensures the continuation of care, and safety of these patients, in collaboration with the patient's primary care office and home care agency.

Conduct a directed physical examination based on the needs of the patient and the physician's agenda.
